Peser, appeals from the Superior Court's adjudication of guilt in a bench trial. The question presented is whether the defendant waived his right to a jury trial. On October 8, 2003, the defendant entered a conditional plea of guilty in exchange for the State's agreement not to pursue a habitual offender charge. The Superior Court sentenced the defendant to probation for five years and fined him \$1,000. The defendant now appeals the Superior Court's judgment on his pro se appeal of the conviction. The defendant has requested an extension of time to file his opening brief. The Superior Court denied the defendant's request on March 18, 2004. The defendant seeks review of the Superior Court's order. Pursuant to Superior Court Criminal Rule 25(a), the defendant had seven days from April 1, 2004 to file his opening brief, unless he requested and received an extension of time from the Superior Court. Neither request for an extension of time nor a motion to withdraw the conditional guilty plea was filed within the seven-day period. Consequently, the defendant's opening brief was due on Monday, April 1, 2004. \*1068 At 4:00 p.m. on Friday, April 5, 2004, the defendant submitted a second, pro se motion seeking an extension of time to file the opening brief.
